TOWNSHIP OF WAINFLEET

By-Law No. 728-81

Being a by-law to designate the Wainfleet Community Centre as **a** building of historic and architectural value or interest.

WHEREAS Council of municipalities may pass by-laws to

designate property within its jurisdiction having determined such property to be of historic or architectural value or interest, pursuant to the Ontario Heritage Act, 1974.

AND WHEREAS it has been determined by the Council that the Wainfleet Community Centre is a property of historic value and interest;

AND WHEREAS notice of intention to designate the Wainfleet Community Centre as being of historic or architectural value or interest has been given in accordance with Section 29 of the Ontario Heritage Act.

AND WHEREAS no notice of objection has been served upon the Clerk of the Municipality of the designation.

NOW THEREFORE the Council of the Corporation of the Township of Wainfleet HEREBY ENACTS AS FOLLOWS:

1. THAT the Wainfleet Community Centre, Part Lot 19, Concession 3, southside of Provincial Highway No. 3 be and is hereby designated a heritage building under the Ontario Heritage Act, 1974.

2. AND THAT this by-law and the reasons for the designation of the said property shall be registered on title.

3. AND THAT the reasons for designating the Wainfleet Community Centre as a heritage building are as listed on Schedule "A" to this by-law.

4. AND THAT a copy of this by-law shall be served upon the Ontario Heritage Foundation.

5. AND THAT this by-law shall come into force, take effect and be passed on the third and final reading hereof.

Schedule "A" to By-law No. 728-81 of the Township of Wainfleet

Reasons for designating the Wainfleet Community Centre as a heritage building.
