## Description of the Land and Purpose and Effect of the Application:

The subject property is located on the south side of Hickey Road west of Augustine Road. The subject property is zoned Residential Lakeshore – RLS.C25 with a Hazard Overlay and currently has a legal non-conforming one-storey single detached dwelling.

An application for a minor variance has been submitted to expand a legal non-conforming building. The applicant proposes to construct a new two-storey single detached dwelling on the existing footprint with 2.98m extending further towards the rear lot line, resulting in a rear yard setback of 4.66m, as well as total lot coverage of 30.91%.

P. 13, Section 45, Subsection 12, states that "the applicant, the Minister or a specified person or public body that has an interest in the matter may within 20 days of the making of the decision appeal to the Tribunal against the decision of the committee by filing with the secretary-treasurer of the committee a notice of appeal setting out the objection to the decision and the reasons in support of the objection accompanied by payment to the secretary-treasurer of the fee charged by the Tribunal as payable on an appeal from a committee of adjustment to the Tribunal". Parties, other than the applicant, the Minister, a specified person or public body, are no longer eligible to file appeals for this application.
